Treasurer’s Report: Edgar was unable to attend. Paul went through the report with those in attendance. There were no questions asked. Motion to approve the treasurer’s report was made first by Shelby Brandsma; seconded by Monica McGauley. Motion passed.

Old Business:

*Uniforms: Volleyball uniforms for 5th/6th grade had been purchased and will be handed out to the players week of August 31. *Points: You can receive points by attending meetings, scoring, line judge, clock, concessions.

*Safeguarding Our Children: Next opportunity to attend session is Sept. 7. You only need to attend 1 training session. Background checks are required every 5 years.

New Business:

*Dance: September 11, 2009, 6:30-9:00. We are looking for parents to help chaperone. Reminder that parents are to donate 12-pack soda or water. Pizzas donated by Richelieu. This is our only fundraiser for the Athletic Association.

*A-league basketball tournament will be held at SKDS this year, 2nd week of February. We are in need of coordinator(s) for this event.

Other business:

*Volleyball fees: All money must be turned into office; not to the coaches. Same goes with any other sport.

*Physicals are good for 2 years. It’s very important to hand in the liability insurance form.

*New Archdiocese rule allows “student-athlete to participate with a non-archdiocesan team in the same sport during the season provided that the student’s priority and commitment is with the parish/school team.” Discussion ensued relating to letting parish (non-school) athletes play on school team: Through an email with Barb Haase, it states: “Our program is school based NOT parish based. This is the reason non-school students cannot participate in SKDS programs. Please refer to the Arch Handbook 09/10 Policies and Regulations for Athletics.”
